Resort Boarding Consent Form

Please read the following and sign below.

1. The Greenbriar Veterinary Hospital and Luxury Pet Resorts shall not be responsible for any illness, injury or death experienced by my pet unless it is the direct result of gross negligence or willful misconduct by Greenbriar Veterinary Hospital and Luxury Pet Resorts or its employees.
2. I understand that attendance by my pet(s) in group activities such as day camp/group play involves interaction with other pet(s). Although the staff at this facility will closely supervise all participants, I accept that play behavior, unknown or undocumented aggression, or participation in routine daily activities can lead to altercations or injuries. I assume the risks of and responsibility for the costs to treat any injuries my pet(s) sustains while playing at this facility. I further understand and accept that in the absence of negligence, the owners and staff of Greenbriar will not be held liable for any injuries or deaths related to my pet(s) participation in these programs.
3. In the event my pet(s) contracts a communicable disease during the time he/she is attending Greenbriar, I assume the risks and accept responsibility for the costs for all treatments. I also agree that Greenbriar may withhold my pet(s) from extras, until he/she has been free of any signs of communicable disease for at least 48 hours. Although risks of acquiring communicable disease are small, I accept them and, in the absence of negligence, agree to hold this facility harmless from expenses incurred for treatment.
4. I understand and agree that if the need arises, emergency medical care for my pet will be sought from Greenbriar Veterinary Hospital and I agree to medical treatment of my pet and to pay all reasonable costs for such treatment. I have been informed that someone from this facility will attempt to call me as soon as the situation is stable, at which time authorization for further care will be transferred to me. If I am unable to be contacted you have the right to administer aid as appropriate, using available veterinarian.
5. Daily boarding charges begin the date my pet is left with Greenbriar Veterinary Hospital and Luxury Pet Resorts and shall be at the rate then enforce. I agree to notify Greenbriar in advance if there is any change in the date my pet is to be picked up. No boarding guest will be released until all charges are paid in full. In the event my pet is not picked up or paid for 7 days from the scheduled day of pick up, I authorize Greenbriar Veterinary Hospital and Luxury Pet Resorts to take any action it desires to place or otherwise rid itself of my pet. I shall be responsible for the complete boarding bill as well as all other charges incurred in the care, maintenance and disposal of my pet, should such become necessary.
6. I agree to pay for reasonable attorney's fees incurred by Greenbriar Veterinary Hospital and Luxury Pet Resorts in the collection of any, boarding, hospital, grooming, or other charges incurred by me or my agent.
7. Your pet's picture or video may be taken and used for Greenbriar Veterinary Hospital and Luxury Pet Resorts advertisement (www.greenbriarpets.com,ect.) or other social media purposes (Facebook,twitter, etc..) I agree that Greenbriar can use all pictures and video taken of my pet.
