\_\_\_\_\_ I authorize Greenbriar to pick up and or drop off the listed above pet(s) to or from the address that I have provided.

\_\_\_\_\_ I authorized Greenbriar to transport my pet(s) to or from their facility.

\_\_\_\_\_ I understand that if I am to send my pets' own food, it is individually bagged per serving with their name on it.

\_\_\_\_\_ I understand that if I send my pet with medications, it must be sent in the original container in which it was prescribed. I must also provide Greenbriar hand written, legible instructions on dosage and when it is to be given. Greenbriar will not accept any medications mixed in with food or in an unmarked bag or container.

\_\_\_\_\_ I understand that I may not send any personal belongings with my pet. These items include bedding, blankets, and toys. Greenbriar provides everything my pet needs while boarding.

\_\_\_\_\_ I understand that I will be given a two hour window of time in which Greenbriar will be able to drop off or pick up my pet and this time frame may be affected by circumstances beyond their control such as inclement weather or traffic.

\_\_\_\_\_ I understand that if I call and ask for a same day transport, my times for pick up or drop off may be limited and an additional fee may apply.

\_\_\_\_\_ I understand that Greenbriar will not pick up or drop off my pet to any outside location such as a deck, back yard, or front yard. Someone must be home when the pet is picked up or dropped off from our transport person.

\_\_\_\_\_ I understand that in the event that Greenbriar arrives to my location and my pet is outside and I am not home, Greenbriar will not pick the pet up until proper arrangements are made. If Greenbriar arrives to return my pet and I am not home to receive them, the transport driver will return my pet to Greenbriar's facility also until other arrangements are made.

\_\_\_\_\_ I understand that the safety of my pet as well as other passengers is Greenbriar's first priority. Therefore, the driver is not permitted to make or accept phone calls while they are driving.

\_\_\_\_\_ I understand that I (the owner) must sign this consent form and return it to Greenbriar prior to my pets transport.
