Rules and Regulations:

- You must be 21 or older to rent Greenbriar Veterinary Hospital & Luxury Pet Resort dog park.
- All organizations or clients renting facilities shall be responsible for the facility being clean and in an orderly state after scheduled use. Should the facilities be left in such a condition to require additional cleanup or maintenance, this expense will be invoiced to the responsible party.
- Greenbriar is not responsible for setting up/tearing down or working the day of the event unless requested ahead of time.
- All dogs must be legally licensed and vaccinated.
- Smoking and the use of tobacco products is prohibited.
- It is your responsibility to have sufficient portable toilets for your guests.
- Greenbriar staff have the right to engage with your guests and discuss Greenbriar services as long as it does not disrupt the day's events.
- A signed Waiver of Liability and a 50% deposit are required to complete a reservation.
- All applications are approved at the discretion of the Greenbriar Administration. Application is not a guarantee of permit issuance.

I also assume all responsibilities for my dog(s), my guest(s) and myself and for any liability caused by my dog(s), my guest(s) and me. I further agree to indemnify and hold harmless and defend Greenbriar Veterinary Hospital & Luxury Pet Resort and its, employees, and any volunteer assisting or working on behalf of Greenbriar Veterinary Hospital & Luxury Pet Resort from and against any and all losses, claims, damages, liabilities, cause of actions, and expenses (including but not limited to court costs and attorney fees), occurring, growing out of, incident to, or resulting directly or indirectly from my use of this facility and surrounding area, including without limitation any losses, claims, damages, liabilities, cause of actions and expenses on account of personal injury to or death of any person or animal, or damages to property of any person or entity.
